The Client and The Company agree as follows:

#### 1. The Services

- A. DVG Show Stables will provide client with 1 group riding lesson per week or biweekly depending on package.
- B. DVG Show Stables will provide the lesson horse, saddle, bridle, and all equipment for the horse.
- C. DVG Show Stables will provide riding instruction and horse tack ups and untacks during covid-19.
- D. Riders will be automatically grouped together with a rider of similar ability and level. This is paramount to our barn culture and philosophy of creating a community that encourages camaraderie, friendship and support. We feel this leads to higher quality riding, lessons, and just plain more fun. During Covid-19 we will only offer semi-private lessons to avoid congestion and ensure safety; this may change as we navigate through covid-19 at the instructor's discretion.

#### 2. Client Requirements

- A. Client must show up on time.
- B. Client must be wearing proper riding attire- boots with heels and riding breeches and an ASTM approved helmet. NO TANK TOPS.
- C. Client must be coachable, positive, and have a good attitude!
- D. During Covid-19 we are limiting one parent per child on the premises and all parties must wear a mask and use hand sanitizer upon arrival.

### 3. Compensation and Payment

- A. Client will put a credit or debit card on file, and it will be automatically charged **\$300** for a one time a week package and **\$525** for two lessons per week at the beginning of each month; if lessons start after the beginning of the month a prorated amount will be charged. This is the cost of your tuition per month and you will be billed beginning on the first day of enrollment and continuing every 30 days thereafter. If client needs to change the credit card on file please ask to complete a new contract form.

### 4. Scheduling

- A. Client will receive a dedicated time and a day of the week where there will be an appropriate school horse and with a group of riders with similar ability reserved each week
- B. If client cannot make their time during a week- DVG Show Stables will allow a maximum of one makeup lesson per month. An attempt will be made to try and find an additional time for the student where there is an appropriate lesson horse and group, however because of the complexities of scheduling- there are no guarantees. Monthly tuition is still due in full when student misses their lessons. If weather does not permit a lesson a horsemanship zoom lesson will be provided. The best way to get the most value out of the program is to make it a priority and a commitment not to miss your dedicated lesson time(s)
- C. If a client at any time feels like he is displaying any symptoms of the Covid-19 virus DO NOT COME TO THE BARN. If you are placed under any quarantine restrictions, we will carry over your billing until you are out of quarantine and healthy. Example- if you are exposed to a person who has the virus and have to undergo a 14-day quarantine.
- D. If client would like to make a long-term change to their dedicated lesson time, they may do so a maximum of 1 time in a 90 day period by calling or texting 760-807-4116 and leaving a voicemail.
- E. If client arrives late for their designated lesson time you will receive a shortened lesson for the time remaining.
- F. If weather or horse shows do no permit for a lesson and there is no opportunity to do a makeup lesson, a credit will be issued for your next month's tuition fee.
