1. The Services

- A. DVG Show Stables will provide client with 1 semi-private riding lesson per week or biweekly depending on package. There is no set time length for each lesson.
- B. DVG Show Stables will provide the lesson horse, saddle, bridle, and all equipment for the horse.
- C. DVG Show Stables will provide riding instruction.
- D. Riders will be automatically grouped together with a rider of similar ability and level. This is paramount to our barn culture and philosophy of creating a community that encourages camaraderie, friendship and support. We feel this leads to higher quality riding, lessons, and just plain more fun.
- E. When riding is unavailable due to weather, the instructor may offer a "dry" lesson on horsemanship. This is in every way just as important as time spent on the horse and will count as a lesson.

2. Client Requirements

- D. Client will be responsible for grooming tacking, untacking, and returning the horse to his stable in proper condition as outlined by the instructor.

3. Compensation and Payment

A. Client will put a credit or debit card on file, and it will be automatically charged \$400 for a one time a week package and \$700 for two lessons per week. This is the cost of your tuition per month and you will be billed beginning on the first day of enrollment and continuing every 30 days thereafter. If client

4. Scheduling

- A. Client will receive a dedicated time and a day of the week where there will be an appropriate school horse and with a group of riders with similar ability reserved each week.
- B. If Client cannot make their time during a week- DVG Show Stables will allow a maximum of one makeup lesson per month. An attempt will be made to try and find an additional time for the student where there is an appropriate lesson horse and group, however because of the complexities of scheduling- there are no guarantees. Monthly tuition is still due in full when student misses their lessons. If the weather does not permit a riding lesson a horsemanship lesson will be provided. The best way to get the most value out of the program is to make it a priority and a commitment not to miss your dedicated lesson time(s)
- C. Client must give 24-hour notice of cancellation. No cancellations due to illness will be received after said 24 hours.
- D. If client would like to make a long-term change to their dedicated lesson time, they may do so a maximum of 1 time in a 90-day period by calling or texting 760-807-4116 and leaving a voicemail.
